❖ How Can I Open an Account with UCFCU? (Click one)

Open an Account Online

- \$30 minimum is required to establish a Primary Savings Account (\$25 is a minimum Savings balance to maintain membership; the additional \$5 is a one-time non-refundable new membership fee.)
- To open a Classic Checking Account a \$25 minimum deposit is required.
- One form of *valid identification (driver's license, ID card, military ID, passport or resident alien card.)

By mail or In Person

- To open your account, print and complete the Invitation to Membership.
- You can bring or mail the Application to the Credit Union.
- \$30 minimum is required to establish a Primary Savings Account (\$25 is a minimum Savings balance to maintain membership; the additional \$5 is a one-time non-refundable new membership fee.)
- To open a Checking Account a \$25 minimum deposit is required
- One form of *valid identification (driver's license, ID card, military ID, passport or resident alien card.)

Customer Identification Program: Under the USA Patriot Act, all financial institutions are required to obtain, verify and record information that identifies each person who opens an account. When you open an account with United Catholics Federal Credit Union (UCFCU), we will ask for your name, address, date of birth, and other identifying information. *Valid physical address as proof of residence.
